

## RELEASE OF SECURITY INTEREST

FOOTHILL CAPITAL CORPORATION, a California corporation having an address at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404, on behalf of itself, its predecessors, successors and assigns (collectively "FOOTHILL"), hereby releases and discharges COOPERVISION, INC., its predecessors, successors and assigns (collectively "COOPERVISION"), from the first-priority security interest granted in all of COOPERVISION's right, title and interest in and to the Collateral to secure the Obligations under the Patent and Trademark Security Agreement, dated as of September 20, 1994, entered into between COOPERVISION and FOOTHILL ("the Security Agreement") pursuant to a contemporaneously executed Loan and Security Agreement ("the Loan Agreement") and other instruments, documents and agreements contemplated or related thereto (collectively, together with the Loan Agreement and Security Agreement, the "Loan Documents").

The Collateral for which FOOTHILL's security interest is hereby released and discharged includes:

- each of the trademarks and rights and interests which are capable of being protected as trademarks, as set forth in Section 1(i) of the Security Agreement, and all of COOPERVISION's right to the trademarks and trademark registrations listed on SCHEDULE A attached to the Security Agreement (also attached hereto), including any and all after-acquired trademark rights pursuant to Section 4 of the Security Agreement, and
- each of the patents and patent applications which were as of the date of the Security Agreement or thereafter may have been owned, issued acquired, or used by COOPERVISION, as set forth in Section 1(ii) of the Security Agreement, and all of COOPERVISION's right, title, and interest in and to the patents and patent applications listed on SCHEDULE B attached to the Security Agreement (also attached hereto), including any and all after-acquired patent rights pursuant to Section 4 of the Security Agreement.

Further, FOOTHILL hereby releases and discharges COOPERVISION from any and all continuing Obligations under the Security Agreement, the Loan
