
ASSIGNATION OF TRADEMARK

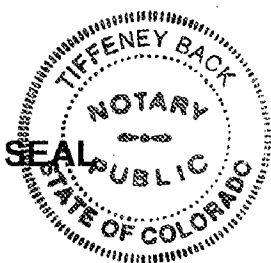
