ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

WHEREAS, Société des Produits Nestlé S.A., a société anonyme organized under the laws of Switzerland and an affiliate of Nestlé USA, Inc., a Delaware corporation ("SPN"), Nestec, Ltd., a corporation organized under the laws of Switzerland and an affiliate of SPN ("Nestec") and together with SPN, "Seller", and Wilbur Chocolate Company, Inc., a Delaware corporation ("Buyer"), have entered into that certain Intellectual Property Purchase and License Agreement, dated as of the date hereof (the "Intellectual Property Purchase and License Agreement"), pursuant to which Seller has agreed to sell, and Buyer has agreed to buy, certain intellectual property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby assigns and transfers to Buyer all of its right, title and interest in and to, if any, to all of Seller's or Seller's Affiliates' right, title and interest, if any, in and to:

(i) the United States and Canadian registered trademarks (or marks for which applications for registration are pending) set forth on Schedule A (collectively, the "U.S. and Canadian Registered Trademarks"), and the goodwill of the Business associated therewith,

(ii) those unregistered trademarks, as used in the United States and Canada, together with the goodwill of the Business associated therewith, set forth under the caption "Unregistered Trademarks" on Schedule B,

(iii) all other trade dress, trademark registrations and trademark applications, logos, designs, copyrights, copyright registrations, if any, as used or registered in the United States and Canada, and owned by Seller or Seller's Affiliates (including, without limitation, all written promotional materials, current and historic ad copy, materials currently published on the Internet, and any such items described on Schedule A) that are used exclusively to conduct the Business as currently conducted in the United States and Canada, together with the goodwill of the Business associated therewith,

(iv) Seller's registration for the internet domain name "Peterschocolate.com"; and

(v) the "Peter's" trademarks are registered in the jurisdictions set forth on Schedule E hereto (collectively, the "Other Registered Trademarks").
