This Assignment made this 11th day of February, 2005, between the Fleet Capital Corporation formerly known as Summit Business Capital Corp. (the "Original Assignee") and Wells Fargo Business Credit, Inc. (the "New Assignee").

Whereas, the Original Assignee is party to a certain Security Agreement dated September 20, 2001, (the "Security Agreement") pursuant to which American Silk Mills Corporation (the "Borrower") granted to the Original Assignee a security interest in certain assets of the Borrower described in the Security Agreement and identified in Exhibit A attached hereto:

Now, Therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, this will confirm that Original Assignee has sold, assigned and transferred to the New Assignee, its successors or assigns, all right, title and interest of the Original Assignee in and to a certain security interest and debt thereto issued to the Original Assignee from the Borrower, as described more fully in the Security Agreement, pursuant to that certain Purchase and Sale Agreement dated as of February 11, 2005.
