

RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated February 11, 2005 by Harris Trust and Savings Bank as hereinafter described;

WITNESSETH:

WHEREAS, Harris Trust and Savings Bank, an Illinois banking corporation with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (the "*Secured Party*") and Johnathan Louis International Ltd., a California corporation with its mailing address at 544 West 130th Street, Gardena, California 90248 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated April 9, 2004 which was recorded in the United States Patent and Trademark Office on April 14, 2004 at Reel 002947, Frame 0365 (the "*Assignment*"), pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks listed on Schedule A attached hereto and certain other property (collectively the "*Trademarks*"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Debtor;

(ii) The goodwill of the business to which each of the Trademarks relates.
