TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is dated this 10th day of March, 2005, by and between Williams Service Group, LLC (successor-in-interest to Williams Service Group, Inc., a Georgia corporation), a Georgia limited liability company ("ASSIGNOR"), and Williams Specialty Services, LLC, a Georgia limited liability company ("ASSIGNEE").

WHEREAS, ASSIGNOR and ASSIGNEE entered into a Bill of Sale dated January 1, 2004 whereby the ASSIGNOR transferred to ASSIGNEE essentially all of the assets which are used in the operation of the ASSIGNOR's division ("Division") known as Williams Specialty Services (the "Transaction");

WHEREAS, in connection with the Transaction, the ASSIGNOR and ASSIGNEE entered into an Assignment and Assumption Agreement dated as of the 1st day of January, 2004 (the "Assumption Agreement"), whereby the ASSIGNOR transferred, assigned and contributed to ASSIGNEE all right, title and interest in certain assets of Assignor including all trademarks and service marks used in the business of the Division;

WHEREAS, ASSIGNOR and ASSIGNEE desire to memorialize the transfer and assignment of a particular trademark in connection with the Transaction in order to record this Assignment with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE, nunc pro tunc effective as of the 1st day of January, 2004, all rights, title, and interest that ASSIGNOR may possess in and to that certain federal trademark registration for the trademark WILLIAMS INSIGHT, Reg. No. 2,029,223 (the "Trademark"), together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by said Trademark.
