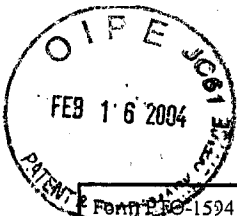

AGREEMENT FOR ASSIGNMENT OF TRADEMARKS

A. C. Assignor and Assignee desire that ownership of its Trademarks be transferred to Assignee.


