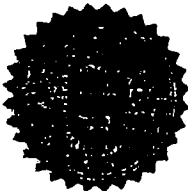

FIRST: The names and state of incorporation of the constituent corporations are: CGI Information Systems & Management Consultants, Inc., a Delaware corporation ("CGI ISMC"), and CGI-AMS Inc., a Delaware corporation ("CGI-AMS").

FIFTH: The merger is to become effective on September 30, 2004 at 8:00 p.m., Eastern Time.


SIXTH: The executed agreement of merger is on file at the principal place of business of CGI-AMS at 4050 Legato Road, Fairfax, Virginia 22033.
