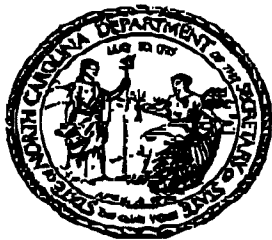

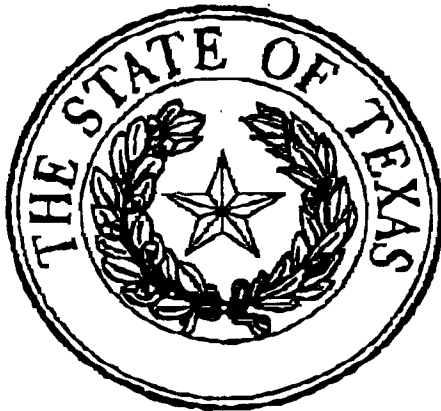

Pursuant to the provisions of Article 5.16 of the Texas Business Corporation Act, the undersigned corporations certify the following articles of merger adopted for the purpose of effecting a merger in accordance with the provision of Part Five of the Texas Business Corporations Act.

1. The parent company, Red Storm Entertainment, Inc. ("Red Storm"), is a corporation organized under the laws of the State of North Carolina.
2. The subsidiary, Wolfpack Studios, Inc. ("Wolfpack"), is a corporation organized under the laws of the State of Texas.
3. Red Storm, as the parent corporation, owns one hundred percent (100%) of the 8,412,500 issued and outstanding shares of common stock in Wolfpack.
4. A resolution and plan of merger was adopted by the Board of Directors of Red Storm on November 25, 2004, in accordance with the laws of North Carolina and Red Storm's organizational documents, and a copy of such resolution is attached to these Articles of Merger.
