

CONFIRMATORY ASSIGNMENT

WHEREAS, on or about the 12th of August, 1999, MONSANTO COMPANY, a Delaware corporation, of 800 North Lindbergh Boulevard, St. Louis, Missouri 63167 ("MONSANTO"), assigned certain trademarks set forth on Exhibit A hereto to "RENESSEN LLC, a Delaware corporation, of 222 Merchandise Mart Plaza, Suite 900, Chicago, Illinois 60654, the successor of the ongoing and existing business or portion thereof of Monsanto Company to which the mark pertains";

WHEREAS, such assignment was recorded in the United States Patent and Trademark Office at Reel No. 1990 and Frame No. 0705 under a cover sheet which designated RENESSEN LLC as a "limited liability corporation";

WHEREAS, MONSANTO and RENESSEN LLC have become aware that RENESSEN has always been and should have been designated in the August 12th 1999 assignment as a "limited liability company formed under the laws of the State of Delaware" not as a "Delaware corporation" or as a "limited liability corporation";

WHEREAS, MONSANTO confirms its assignment as of the 12th of August, 1999 to RENESSEN LLC, a limited liability company formed under the laws of the State of Delaware ("RENESSEN"), of the trademarks set forth on Exhibit A hereto, which at that time MONSANTO had intended to use in commerce and had filed applications indicating that intention, but for which MONSANTO had not yet filed an allegation of use under §§ 1 (c) or 1 (d) of the Trademark Act;

WHEREAS, MONSANTO hereby confirms its assignment to RENESSEN as of the 12th of August, 1999, of the applications as part of the entire business or portion thereof to which the mark pertained as required by 15 U.S.C. § 1060;

WHEREAS, RENESSEN, having a current address of 3000 Lakeside Drive, Suite 300 South, Bannockburn, IL 60015, as the successor of the ongoing and existing business or portion thereof of MONSANTO to which the marks pertain, remains desirous of acquiring said marks and the pending intent-to-use applications therefor as of the 12th of August, 1999;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, MONSANTO does hereby confirm its assignment to RENESSEN as of the 12th of August, 1999, of all right, title, and interest in and to the marks and the goodwills of business symbolized thereby.
