WHEREAS RESEARCH ONLINE INTERNATIONAL, INC. will file amendments to the applications to correct the applicant name; and



Assignor acknowledges and agrees that, pursuant to this Assignment of the TRADEMARKS, ASSIGNOR shall not use the names "ROI", "Research Online International" or any confusingly similar name in connection with any computer research services, including but not limited to business information retrieval or analysis, and consulting services.
