TERMINATION OF SECURITY INTEREST

This **TERMINATION OF SECURITY INTEREST**, dated as of February 16, 2005, is made by Wilmington Trust Company and John Beeson (collectively, the "Collateral Trustees").

WHEREAS, pursuant to that certain Security Agreement, dated November 15, 2002 (the "Security Agreement"), Broadwing Inc. (f/k/a Cincinnati Bell Inc.) (the "Grantor") granted a security interest in favor of the Collateral Trustees with respect to the Collateral (as defined in the Security Agreement);

WHEREAS, the Grantor executed an Intellectual Property Security Agreement (the "IP Security Agreement"), dated November 15, 2002, pursuant to which the Grantor confirmed the grant of the security interest to the Collateral Trustees under the Security Agreement with respect to the trademarks set forth on Schedule A attached hereto (the "Trademarks");

WHEREAS, the IP Security Agreement was recorded at the United States Patent and Trademark Office on February 6, 2003 at Reel 2663 and Frame 0317; and


WHEREAS, the Collateral Trustees have agreed to terminate and release their security interest in the Trademarks.

NOW, THEREFORE, for valuable consideration, the Collateral Trustees hereby terminate and release on to the Grantor, without warranty of any kind except as expressly provided under the Security Agreement, the security interests granted to the Collateral Trustees in the following:

- 1. the Trademarks;
- 2. all goodwill of the business connected with the use of, and symbolized by, each of the foregoing; and
- 3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of the foregoing or (ii) injury to the goodwill associated with the foregoing.

IN WITNESS WHEREOF, the Collateral Trustees have caused this Termination of Security Interest to be duly executed as of the date first set forth above.
