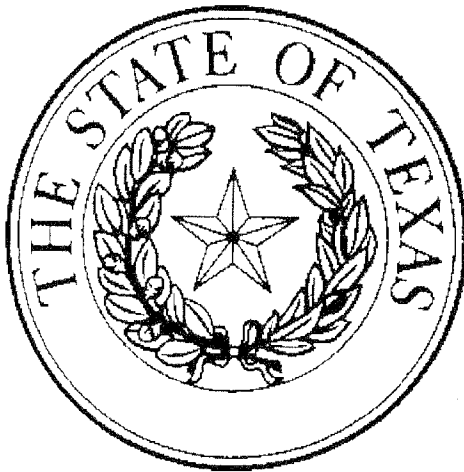

**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
AMSOLV HOLDING COMPANY**

Corporations Section

1. The name of the corporation is AmSolv Holding Company.
2. The amendment changes Article One of the corporation's Articles of Incorporation by deleting said Article One in its entirety and replacing it with the following new Article One:

ARTICLE ONE

The name of the corporation is AHC Logistics, Inc.

3. The amendment was adopted by a majority of the shareholders of the corporation on February 17, 2005.
4. The amendment to the articles of incorporation has been approved in the manner required by the Texas Business Corporation Act and by the constituent documents of the corporation.
