RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of March 11, 2005 by Heller Financial, Inc., as Agent ("Heller").

WHEREAS, Heller and Liberty Safe and Security Products, Inc. ("Assignor"), entered into that certain Assignment for Security of Patents, Trademarks and Copyrights (the "Trademark Security Agreement"), dated as of December 16, 1999;

WHEREAS, the Trademark Security Agreement granted Heller a security interest in, among other things, certain trademarks, tradenames, corporate names, company names, business names, fictitious business names, service marks, logos, trade styles, terms, designs and other business identifiers, and all registrations and recordings thereof, and all applications in connection therewith ("Trademarks"), including, without limitation, the Trademarks listed on Schedule A attached hereto as security for certain obligations of Assignor to Heller (the "Obligations");

WHEREAS, Heller recorded the Trademark Security Agreement on February 2, 2000 at Reel 002025, Frame 0001 in the United States Patent and Trademark Office; and

WHEREAS, Assignor has satisfied all of the Obligations and has requested that Heller release its security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Heller hereby agrees as follows:

Heller hereby fully releases, cancels and terminates its security interests in and liens on:

(a) all of Assignor's now existing or hereafter acquired right, title and interest in and to: all Trademarks, including, without limitation, all Trademarks which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Trademarks have appeared or appear and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of Assignor's business connected with the use of or symbolized by Trademarks; and

(c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Assignor against third parties for infringement of the Trademarks or of any license with respect thereto.

Heller further agrees, at the sole cost and expense of Assignor, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release and termination.
