## TERMINATION AND RELEASE

OF

## INTELLECTUAL PROPERTY SECURITY

This Termination and Release of Intellectual Property Security (this "Termination") is executed by the secured parties on the signature page hereto (the "Secured Parties") in favor of Zeevo, Inc., a Delaware corporation (the "Debtor"), and is effective as of March 17, 2005.

### RECITALS

A. WHEREAS, Debtor and Comdisco, Inc. entered into that certain Reimbursement and Security Agreement dated as of November 16, 2000, as amended by that certain Amendment No. 1 to Reimbursement and Security Agreement dated as of July 2, 2001 and that certain Letter Agreement dated as of February 24, 2003 (the "Reimbursement Agreement").

B. WHEREAS, Comdisco Ventures, Inc. ("Comdisco"), is the successor in interest to Comdisco, Inc.

C. WHEREAS, Debtor and Comdisco entered into that certain Restructuring Agreement dated as of July 16, 2003 (the "Restructuring Agreement"), that restructured certain payments due under the Reimbursement Agreement.

D. WHEREAS, in connection with the Restructuring Agreement, Debtor and Comdisco entered into a Reaffirmation and Grant of Security Interest in Patents and Trademarks, dated as of July 16, 2003 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office at Reel 014462, Frame 0200 with respect to patents, and Reel 2805, Frame 0759 with respect to trademarks, for the purpose of securing payment and performance of Debtor's obligations under the Restructuring Agreement.

E. WHEREAS, pursuant to the Security Agreement, Debtor pledged and granted to Comdisco a security interest in Debtor's entire right, title and interest in and to Debtor's intellectual property, including without limitation the patents and patent applications identified on Schedule A and the trademarks and trademark applications identified on Schedule B attached hereto.

F. WHEREAS, the Secured Parties, as the successors in interest to Comdisco, entered into that certain Amendment No. 1 to Restructuring Agreement, dated as of September 29, 2003 (the "Amendment"), whereby the Secured Parties succeeded to all of the right, title and interest of Comdisco in the Restructuring Agreement and the Security Agreement.

G. WHEREAS, in connection with the Amendment, Comdisco assigned the Security Agreement to the Secured Parties (the "Assignment") which Assignment was recorded with the United States Patent and Trademark Office at Reel 014653, Frame 0611 with respect to patents, and Reel 2858, Frame 0271 with respect to trademarks, for the purpose of securing payment and performance of Debtor's obligations under the Amendment.

H. WHEREAS, the Secured Parties have agreed to terminate and release their security interests in all intellectual property of the Debtor, including without limitation the patents and patent applications identified on Schedule A and the trademarks and trademark applications identified on Schedule B attached hereto as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Parties hereby terminate and release their security interests in Debtor's intellectual property, including without limitation the patents and patent applications identified on Schedule A and the trademarks and trademark applications identified on Schedule B attached hereto, and the Secured Parties hereby assign and transfer to Debtor, without representations, warranty or recourse (other than a warranty that the Secured Parties have not assigned or transferred their rights, titles and interests in and to the intellectual property to any other person or entity), all of the Secured Parties rights, titles and interests in and to the intellectual property, including without limitation the patents and patent applications identified on Schedule A and the trademarks and trademark applications identified on Schedule B attached hereto, effective as of the date set forth above. The Secured Parties will execute such further documents as deemed reasonably necessary by Debtor to confirm and effect this termination and release.
