2. Administrative Agent hereby reassigns, grants and conveys to T-Netix, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademarks, the applications and registrations thereof, and the goodwill of T-Netix’s business connected with the use of and symbolized by the Trademarks.
