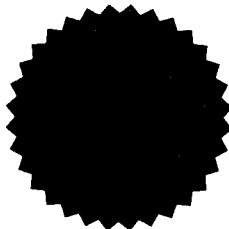

of the General Corporation Law of
the State of Delaware

FIRST: That the Board of Directors of the Corporation, at a meeting held on February 17, 2005, unanimously duly adopted a resolution amending Article FIRST of the Amended and Restated Certificate of Incorporation of the Corporation to read in its entirety as follows:

"FIRST: The name of the corporation is Groove Mobile, Inc. (the "Corporation")."
