**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (this "Release") is made as of this <sup>21<sup>st</sup></sup> day of March, 2005, by LaSalle Bank National Association, as the Administrative Agent for all the Lenders party to the Credit Agreement (as hereafter defined), having an office at 135 South LaSalle Street, Chicago, Illinois 60603 (the "Secured Party"), in favor of Eagle Pack Pet Foods, Inc., a Delaware corporation (the "Debtor").

WHEREAS, the Secured Party and the Debtor are parties to that certain Credit Agreement dated as of September 24, 2004 (the "Credit Agreement");

WHEREAS, the Debtor's obligations under the Credit Agreement are secured in part by (i) that certain Trademark Security Agreement by the Debtor in favor of the Secured Party dated as of September 24, 2004 (the "Trademark Security Agreement") and (ii) that certain Guaranty and Collateral Agreement by the Debtor and Eagle Pack Holdings, Inc. in favor of the Secured Party dated as of September 24, 2004 (the "Guaranty and Collateral Agreement");

WHEREAS, the Debtor has requested that the Secured Party release its security interest in the registered trademark listed on Schedule I attached hereto; and

WHEREAS, the Secured Party has agreed to such request as set forth in this Release,

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Secured Party, for the benefit of the Debtor, hereby unconditionally and expressly releases, terminates and extinguishes any and all of its right, title and interest in, to and under: (a) the trademark listed on Schedule I attached hereto; (b) all now owned or existing or hereafter arising trademarks, registrations of trademarks and applications for registration, relating solely to the trademark listed on Schedule I attached hereto; (c) the entire goodwill of or directly associated with the business now or hereafter conducted by Debtor directly connected with and symbolized by the trademark listed on Schedule I attached hereto or the trademarks, registrations and applications set forth in the preceding clause (b); and (d) all other collateral in which liens and security interests were established solely in connection with the trademark listed in Schedule I under and pursuant to the Trademark Security Agreement and the Guaranty and Collateral Agreement.

This Release shall be binding upon the Secured Party's legal representatives, assigns and successors.
