NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that for good and valuable consideration paid to it, the receipt and sufficiency of which are hereby acknowledged, Happy Guests International, Inc. does assign and transfer unto Estelle McDoniel the entire right, title and interest in and to said trademark, registration and the goodwill of the business in connection with which said trademark is used, all rights to develop, market, manufacture, sell, and offer to sell products having a central theme relating to casinos and casino games using the trademark that may have been developed, marketed, manufactured, sold, and offered to sell by McDoniel, including without limitation the Original Funsters Casino Diary and Game Book, the Funsters Lucky Screen Cloth, the Funsters Memory Card Game, and the Funsters Gift Pak, together with Assignor's rights and interest in the "afunster.com" domain name and all other domain names that incorporate the term "funster." and all claims for damages by reason of past infringement of the trademark and registration, and the right to sue for and collect such damages.

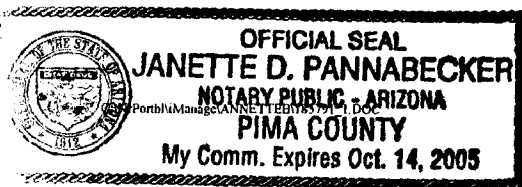
