THE RESTATED ARTICLES OF INCORPORATION
OF
PLUMBMASTER, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Restated Articles of Incorporation.

ARTICLE I

The name of the corporation is Plumbmaster, Inc. The filing number issued to the corporation by the secretary of state is 30382800.

ARTICLE II

The amendment changes the restated articles of incorporation to change the article that names the corporation. Article One in the Restated Articles of Incorporation is amended in its entirety to read as follows:

The name of the corporation is Plumbing Holding, Inc.

ARTICLE III

The date of adoption of the amendment by the sole shareholder of the corporation was on December 18, 2003.

ARTICLE IV


The amendment to the restated articles of incorporation has been approved in the manner required by the Texas Business Corporation Act and by the constituent documents of the corporation.
