TRADEMARK ASSIGNMENT



2. Assignor further assigns to Assignee all causes of action and related remedies arising out of or related to past, present or future infringement or misappropriation of the SIGNING TIME Registration.
3. Each party agrees that it shall execute any and all further or additional instruments as necessary in order to carry out the terms and purposes of this Agreement, including providing documentation of this Agreement to the U.S. Patent and Trademark Office.
4. This Trademark Assignment contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof. The recitals of this Agreement are hereby fully incorporated into this Agreement.
