FIRST: That this corporation was incorporated on the 13th day of November, 1968, pursuant to the General Corporation Law of the State of Delaware.

FURTHER RESOLVED, that the proper officers of this corporation be and they hereby are directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge DANLY MACHINE CORPORATION and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State and a certified copy recorded in the office of the Recorder of Deeds of New Castle County and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be in anywise necessary or proper to effect said merger.

FIFTH: The merger shall be effective at 10:00 A.M. on August 30, 1985.
