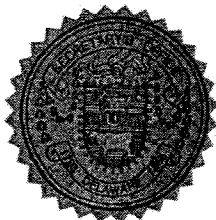





C. § 18-101 et seq.) and the General Corporation Law of the State of Delaware (8 Del. C. § 101, et seq.) (the "GCL").

1. The Company's name when it was originally incorporated was GDS Newco Inc., and the Company's name immediately prior to the filing of this Certificate of Conversion to Limited Liability Company was G. D. Searle & Co.

4. The conversion of the Company to a Delaware limited liability company has been approved in accordance with the provisions of Section 228 and Section 266 of the GCL.
5. The conversion of the Company to a Delaware limited liability company shall be effective on December 31, 2000 at 11:59 p.m. Eastern Standard Time.
