- 2. Article I of the Articles of Incorporation of this corporation is amended to read as follows:

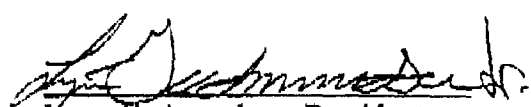

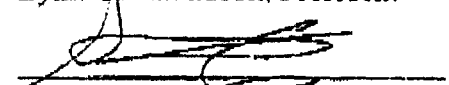
The name of this corporation is DBS MANAGEMENT GROUP, INC."
