TERMINATION OF TRADEMARK SECURITY INTEREST

This **TERMINATION OF TRADEMARK SECURITY INTEREST** is executed as of June 11, 2004 by LaSalle Business Credit, LLC ("Lender"), with reference hereby made to that Loan and Security Agreement, dated as of June 13, 2001 (as the same may be amended, modified or otherwise supplemented from time to time, the "Loan Agreement") between Pumpkin Ltd. d/b/a Pumpkin Masters, Inc., as ("Borrower") and Lender.

WHEREAS, pursuant to the Loan Agreement, Borrower (d/b/a Pumpkin Masters, Inc.) executed and delivered to the Lender the Trademark Security Agreement between the Borrower and Lender and a related Trademark Assignment of Security, each dated as of June 13, 2001 (collectively, the "Trademark Security Agreement") with respect to the collateral listed on Schedule A attached hereto (the "Collateral");

WHEREAS, all obligations due under the Loan Agreement have been paid in full and no outstanding obligations remain due and owing.

For good and valuable consideration, receipt of which is hereby acknowledged, the Lender:


- (a) terminates the Trademark Security Agreement;
- (b) releases the liens and security interests granted to it in the Collateral pursuant to the Trademark Security Agreement and acknowledges, agrees and confirms that it has no right, title or interest in or to (or security interest in) the Collateral; and
- (c) to the extent that the Lender shall be deemed to have any right, title or interest in the Collateral pursuant to the Trademark Security Agreement, re-transfers and reassigns to the Borrower all of such right, title and interest.

This Termination of Trademark Security Interest shall be governed by the laws of the State of New York and shall relate solely to the Trademark Security Agreement.
