

THIS ASSIGNMENT is made the 29<sup>th</sup> October 2004

**BETWEEN:**

- (1) **MAMAS & PAPAS (RETAIL) LIMITED**, a company incorporated under the laws of England registered number 1529849 formerly known as MAMA'S AND PAPA'S LIMITED and having its registered office at Colne Bridge Road, Huddersfield, West Yorkshire, HD5 ORH (the "Assignor"); and
- (2) **MAMAS & PAPAS (HOLDINGS) LIMITED**, a company incorporated under the laws of England registered number 04992401 and having its registered office at Colne Bridge Road, Huddersfield, West Yorkshire, HD5 ORH (the "Assignee").

**RECITAL**

- (1) The Assignor is the proprietor of certain trade marks.
- (2) The Assignee wishes to acquire and the Assignor is prepared to assign the said trade marks to the Assignee subject to the provisions of this Assignment.

**IT IS NOW HEREBY AGREED** as follows:-

1. **Definitions**

1.1 In this Deed of Assignment the following expression shall have the following meaning:

**"Marks"** means the trade mark applications set out in Schedule 1 and all registered trade marks granted pursuant thereto;

**"Rights"** means all property right title and interest in the Marks together with all and any related common law rights including all accrued rights to sue in respect of infringements and all related goodwill;

1.2 The headings in this Agreement are for convenience only and do not affect its interpretation.

1.3 The Schedules form an integral part of this Assignment.

- 1.4 Words importing the singular include the plural and vice versa. Words importing a gender include every gender and reference to persons includes individuals, companies, corporations, firms or partnerships.
- 1.5 All sums payable under this Agreement are exclusive of any applicable tax or duty payable upon such sums which shall be added if appropriate at the rate prevailing at the relevant tax point.
- 1.6 The words and phrases "other" "including" and "in particular" shall not limit the generality of any preceding words or be construed as being limited to the same class as any preceding words where a wider construction is possible.
- 1.7 References to any statute or statutory provisions shall include any provision which supersedes or re-enacts it or modifies the legislation and shall also include any subordinate legislation.

2. **Assignment**

Further to an assignment dated 29 March 2004 and made between the parties hereto and in consideration of the payment of the sum of £1 (one pound) by the Assignee to the Assignor (receipt of which is hereby acknowledged) the **ASSIGNOR HEREBY ASSIGNS** the Rights to the Assignee with full title guarantee.

3. **Further Assurance**

The Assignor covenants with the Assignee to do all such acts and to execute all such deeds and documents as may be necessary or expedient for perfecting the Assignee's title to the Marks and/or to enable the Assignee to enjoy the full benefit of the Marks hereby assigned pursuant to this Assignment.

4. **Severance**

If any provision of this Assignment is or becomes void or unenforceable, it shall be deemed to be cancelled herefrom without affecting the remainder of this Assignment which will remain in full force and effect.



5. **Law**

This Agreement shall be governed in accordance with the laws of England and Wales.

6. **Jurisdiction**

Any dispute arising under this Agreement shall be subject to the exclusive jurisdiction of the English courts and the parties waive any objection to proceedings in such courts on the grounds of venue or on the grounds that proceedings have been brought in an inappropriate forum.
