Assignor agrees to execute and deliver at the request of Assignee, all papers, instruments,


and assignments, and to perform any other reasonable acts the Assignee may require in order to

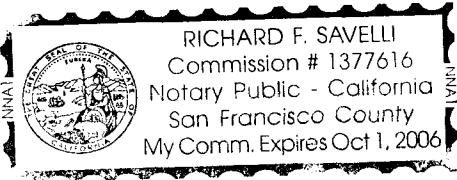
