RELEASE OF SECURITY INTEREST
(TRADEMARKS)

THIS RELEASE OF SECURITY INTEREST (this "Release"), dated as of March 17, 2005, is made in favor of DATA TRANSMISSION NETWORK CORPORATION, a corporation organized under the laws of Delaware (the "Grantor"), by WACHOVIA BANK, NATIONAL ASSOCIATION, as senior collateral agent (the "Senior Collateral Agent").

WHEREAS, the Grantor is a party to (i) that certain Senior Security and Pledge Agreement, dated as of October 31, 2003 (as amended, modified or otherwise supplemented from time to time, the "Senior Security Agreement"), among the Grantor, DTN and the other subsidiary guarantors referred to therein and the Senior Collateral Agent, pursuant to which, among other things, the Grantor has granted to the Senior Collateral Agent, a security interest in the Trademarks identified on Schedule A attached hereto (collectively, the "Trademark Collateral") and (ii) that certain Trademark Security Agreement Supplement to the Senior Security Agreement, dated October 31, 2003 (the "Trademark Supplement");

WHEREAS, the Trademark Supplement was recorded in the United States Patent and Trademark Office on November 3, 2003 under Reel No. 002740 and Frame No. 0963;

WHEREAS, the Grantor and the Senior Collateral Agent wish to record in the United States Patent and Trademark Office a notice of the release of the security interest granted in the Trademark Collateral; and

WHEREAS, the capitalized terms used herein and not otherwise defined herein or where no definition is referenced shall have the meanings ascribed to them in the Senior Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, the Senior Collateral Agent agrees as follows:

1. Release. The Senior Collateral hereby releases and discharges its security interest in and lien upon the Trademark Collateral.

2. Further Assurances. The Senior Collateral Agent acknowledges and agrees to execute and deliver all such other documents and statements reasonably requested by the Grantor to further evidence or effect the release set forth in Section 1 above.

3. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, EXCLUDING ANY CONFLICTS-OF-LAWS RULES THAT WOULD OTHERWISE CAUSE THE LAWS OF ANY OTHER JURISDICTION TO APPLY.
