IN WITNESS THEREOF, the ASSIGNOR has caused this Assignment to be executed by a duly authorized representative as of the date executed below.

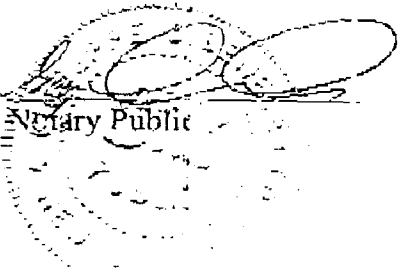
