**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of March 29, 2005, is made by GE BUSINESS CAPITAL CORPORATION, formerly known as TRANSAMERICA BUSINESS CREDIT CORPORATION, ("GBCC"), pursuant to the termination of the Patent and Trademark Security Agreement dated as of January 19, 2001 (the "Security Agreement"), by and among, GBCC and AFFINITY CORPORATION ("AFFINITY").

**W I T N E S S E T H**

WHEREAS, pursuant to the Trademark Security Agreement by and among AFFINITY and GBCC dated January 19, 2001 and recorded with the U.S. Patent and Trademark Office on February 2, 2001 at Reel/Frame No. 2236/0632, AFFINITY granted GBCC a security interest in its state and federal trademark applications and registrations; all common law and other rights in and to the trademarks in the United States or any state thereof; all goodwill symbolized by the trademarks; and all rights and interests pursuant to licenses or other contracts in favor of such Grantor pertaining to any trademarks, trademark registrations or trademark rights ("Trademark Collateral");

WHEREAS, GBCC acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made;

WHEREAS, AFFINITY has requested that GBCC release its security interest in the Trademarks, as defined in the Security Agreements in connection with the termination of the Security Agreements (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, GBCC hereby RELEASES, without recourse, all of its security interest in the Trademarks, listed on Schedule A attached hereto and incorporated herein by reference, and any other collateral described in the Security Agreements.

GBCC agrees to provide AFFINITY with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.

IN WITNESS WHEREOF, GBCC has executed this Release as of the date first set forth above.

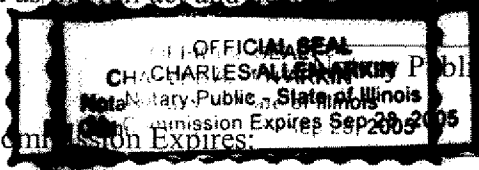
