**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") dated February 24, 2005 is made by **FLEET NATIONAL BANK**, 7111 Valley Green Road, Fort Washington, PA, 19034, acting in its capacity as agent for the Secured Parties referred to in the Agreements identified below (in such capacity, the "Agent") under a Security Agreement and Grant of Security Interest, both dated September 24, 2003, (the "Agreements"), by and between **IRVING TISSUE, INC.**, a Delaware Corporation, ("Debtor") and the Agent;
