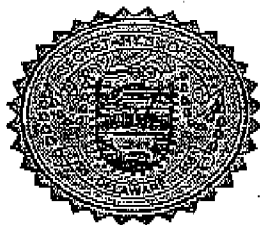

of this certificate of conversion is United States Steel LLC.

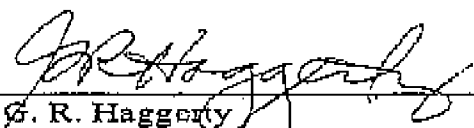
