TERMINATION AND RELEASE
OF
TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT

THRU-PUT CORPORATION

TERMINATION AND RELEASE OF TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT, dated as of April 26, 2002, by **FLEET NATIONAL BANK** (f/k/a BankBoston, N.A.), a national banking association with its head office at 100 Federal Street, Boston, Massachusetts 02110, as agent (hereinafter in such capacity, the "Agent"), in connection with the Revolving Credit and Term Loan Agreement, dated as of January 12, 2000 (as heretofore amended, and in effect, the "Credit Agreement"), by and among Mapics, Inc., a Georgia corporation (the "Borrower"), the Agent and the lending institutions party thereto (the "Banks").

WHEREAS, in connection with the Credit Agreement, Thru-Put Corporation (f/k/a TPTI Acquisition, Inc., a Delaware corporation (the "Company") and the Agent entered into a Trademark Collateral Security and Pledge Agreement, dated as of January 12, 2000 (the "Trademark Agreement"), which Trademark Agreement was recorded January 20, 2000 with the United States Patent and Trademark Office at Reel 002021, Frame 0870 for the purpose of securing payment and performance of the Obligations (as defined in the Credit Agreement);

WHEREAS, pursuant to the Trademark Agreement, the Company granted to the Agent, for the benefit of the Agent and the Banks, a security interest in, and granted, assigned and conveyed to the Agent, for the benefit of the Agent and the Banks, by way of collateral security, the Company's entire right, title and interest in and to, the Pledged Trademarks (as defined in the Trademark Agreement); and

WHEREAS, the Agent has agreed to terminate and release the Trademark Agreement and assign and transfer to the Company its right, title and interest in the Pledged Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates and releases the Trademark Agreement and assigns and transfers to the Company, without representation, warranty or recourse, all of the Agent's right, title and interest in and to the Pledged Trademarks, including without limitation the trademarks listed on Exhibit A attached hereto, effective as of the date set forth above.
