6) on information and belief, the actual original applicant on the application that resulted in U.S. Trademark Registration No. 2,237,323 was Beckley-Cardy, Inc.;



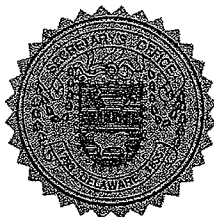
