

ASSIGNMENT OF TRADEMARKS

WHEREAS, AEC ONE STOP GROUP, INC., a Delaware corporation having a principal place of business at 4250 Coral Ridge Drive, Coral Springs, Florida 33065 (hereinafter referred to as "ASSIGNOR"), desires to assign all of its right, title and interest in and to the trademark applications and registrations as set forth in the attached Schedule (hereinafter referred to as the "TRADEMARKS"), including the entire business or portion thereof to which the TRADEMARKS pertain, together with the goodwill of the business associated with the TRADEMARKS to ALL MEDIA GUIDE, LLC, a Delaware limited liability company, having a principal place of business at 1168 Oak Valley Drive, Ann Arbor, Michigan 48108 (hereinafter referred to as "ASSIGNEE");

WHEREAS, the parties desire to formalize said assignment and record same in the U.S. Patent and Trademark Office;

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR hereby assigns the TRADEMARKS, the entire business or portion thereof to which the TRADEMARKS pertain, and the entire right, title and interest in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS; and

ASSIGNOR, does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States, to record said assignment so as to show ownership of the TRADEMARKS in ALL MEDIA GUIDE, LLC, the Assignee; and

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS and registrations herein assigned.
