
WHEREAS, capitalized terms not otherwise defined herein shall have the meaning set forth in the Asset Purchase Agreement; and

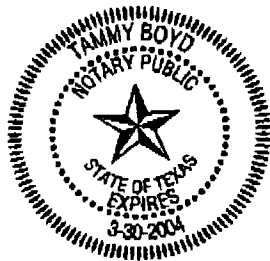
