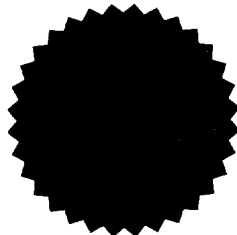

FOURTH: The merger is to become effective on March 31, 2005.


