**THIRD AMENDMENT TO INTELLECTUAL  
PROPERTY SECURITY AGREEMENT**

THIS THIRD AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Amendment") is executed and delivered as of the 1st day of October, 2004, by CANADIAN IMPERIAL BANK OF COMMERCE, in its capacity as administrative agent for the Credit Parties (as defined in the Credit Agreement described below) (the "Administrative Agent")

**WITNESSETH:**

WHEREAS, Ziff Davis Media Inc., a Delaware corporation (the "Borrower"), CIBC World Markets Corp., as lead arranger and bookrunner (the "Lead Arranger"), Deutsche Bank Trust Company Americas, as syndication agent (the "Syndication Agent"), Fleet National Bank, as documentation agent (the "Documentation Agent"), the Administrative Agent and the other Credit Parties party hereto (the "Credit Parties") are parties to that certain Amended and Restated Credit Agreement dated as of August 12, 2002, as amended by that certain First Amendment to Amended and Restated Credit Agreement dated as of September 17, 2002, as further amended by that certain Second Amendment to Amended and Restated Credit Agreement dated as of July 1, 2004 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"); and

WHEREAS, the Administrative Agent has agreed to act as agent for the benefit of the Credit Parties in connection with the transactions contemplated by the Credit Agreement; and

WHEREAS, Ziff Davis Publishing Holdings, Inc., a Delaware corporation (the "Pledgor") is a direct Subsidiary (as defined in the Credit Agreement) of the Borrower and as such has realized and will continue to realize substantial benefits from the extension of credit to the Borrower pursuant to the Credit Agreement; and

WHEREAS, to secure the prompt and complete payment, observance and performance of, among other things, (a) the obligations of the Pledgor arising from that certain Amended and Restated Subsidiary Guaranty dated as of July 13, 2001, amending and restating that certain Subsidiary Guaranty dated as of April 5, 2000, as reaffirmed by that certain Reaffirmation Agreement dated as of August 12, 2002, and (b) all Obligations (as defined in the Credit Agreement) (other than contingent indemnity obligations) of the Borrower under the Credit Agreement (including, without limitation, any interest, fees and other charges in respect of the Credit Agreement and the other Loan Documents that would accrue but for the filing of an Insolvency proceeding with respect to the Borrower, whether or not such claim is allowed in such Insolvency proceeding), the Pledgor and the Administrative Agent executed and delivered that certain Intellectual Property Security Agreement dated as of April 5, 2000, as amended by that certain First Amendment to Intellectual Property Security Agreement dated as of December 10, 2001, as further amended by that certain Second Amendment to Intellectual Property Security Agreement dated as of August 12, 2002 (the "IP Security Agreement"); and

WHEREAS, pursuant to the terms of the IP Security Agreement, the Administrative Agent is authorized by the Pledgor to modify the IP Security Agreement unilaterally by amending Schedule 1 attached thereto to include any new Trademarks (as defined in the IP Security Agreement), and any new Copyrights (as defined in the IP Security Agreement) in respect of which the Pledgor has obtained rights, or become entitled to the benefits thereof, after the Agreement Date (as defined in the Credit Agreement);

NOW, THEREFORE, in consideration of the foregoing, the IP Security Agreement is hereby modified as follows:

1. Amendment to Schedule 1. The IP Security Agreement is hereby amended by supplementing Schedule 1 thereto with the new Trademarks listed on Exhibit A attached hereto.
2. Amendment to Schedule 3. The IP Security Agreement is hereby amended by supplementing Schedule 3 thereto with the new Copyrights listed on Exhibit B attached hereto.
3. No Other Amendment or Waiver. Except as specifically modified and amended hereby, the text of the IP Security Agreement (including all schedules thereto) and all other Loan Documents shall remain unchanged and in full force and effect.
4. Governing Law. This Amendment shall be construed and enforced, and all rights and duties of the parties shall be governed by in all respects in accordance with the laws and decisions of the State of New York.
5. Loan Document. This Amendment shall be deemed to be a Loan Document for all purposes.
