TO WHOM IT MAY CONCERN

DECLARATION

Bühler Holding AG, CH-9240 Uzwil/Switzerland, is the holding company of the Bühler Group and the parent company of Bühler AG, CH-9240 Uzwil/Switzerland, and of Richard Frisse GmbH, D-32107 Bad Salzuflen/Germany.

Bühler Holding AG is the owner of all trade marks belonging to the trade mark family „FRISSE“, namely:

- „FRISSE“
- „BÜHLER SYSTEM FRISSE“
- „FRISSE-LOGO“

Although Richard Frisse GmbH, Bad Salzuflen, is not and has never been the owner of the trade marks belonging to the trade mark family „FRISSE“, they could use these trade marks during the last few years for the following reason:

On the date of November 7, 1974 Gebrüder Bühler AG, Uzwil/Switzerland, established a subsidiary in Konstanz/Germany called Gebrüder Bühler GmbH. On the date of July 10, 1986 Gebrüder Bühler GmbH, Konstanz/Germany took over the private trading firm Richard Frisse having its registered office in Bad Salzuflen/Germany.

On the date of July 11, 1986 the **Frisse AG** was established, at first having its registered office in Oberuzwil, then in Uzwil. Subsequently, the trade mark „FRISSE“ was registered by Frisse AG on August 8, 1986 for the first time. On the date of September 10, 1986 Gebrüder Bühler GmbH, Konstanz/Germany changed its company name into Frisse GmbH, Konstanz. On the date of December 10, 1986 the Frisse GmbH changed its company name into Richard Frisse GmbH and relocated its registered office from Konstanz to Bad Salzuflen.

On the date of December 15, 1986 Gebrüder Bühler AG, Uzwil/Switzerland, assigned and transferred its shares from Richard Frisse GmbH to Frisse AG, Uzwil.

Gebrüder Bühler AG, Uzwil/Switzerland, the later Bühler AG, changed its company name into Bühler International AG as a result of the legal re-structuring of the Bühler Group in the year 1992 and merged with Frisse AG, Uzwil, on the date of May 6, 1992. Consequently, the trade mark family „FRISSE“ registered in the name of Frisse AG, passed over to Bühler International AG. As a consequence of this merger, the subsidiary Richard Frisse GmbH, Bad Salzuflen, became a subsidiary of Bühler International AG.



On the date of February 9, 1999, Bühler International AG concluded a trade mark licence agreement with Richard Frisse GmbH, Bad Salzuflen/Germany.

On June 7, 2000, Bühler International AG merged with Bühler Holding AG according to article 748 Swiss Code of Obligations. Hence, the trade mark family "FRISSE", registered in the name of Bühler International AG, passed over with all other assets and liabilities to Bühler Holding AG.
