The foregoing includes, and Assignor hereby assigns, sells and transfers to Assignee, the goodwill symbolized by the Assigned Trademarks. Assignee accepts such assignment, and assumes (and shall pay, perform and discharge when due) all obligations with respect to such Assigned Trademarks from and after the date of this Trademark Assignment. To the extent there is any conflict between the terms and conditions of this Trademark Assignment and the terms and conditions of the IP Agreement, the terms and conditions of the IP Agreement shall control.


