ASSIGNMENT OF TRADEMARKS

This Agreement is dated this 13th day of April, 2005, by and between Sansora International, Inc., an Arizona corporation (formerly Lebensart Technology Arizona, Inc., an Arizona corporation) ("Assignor") and Starwood Hotels & Resorts Worldwide, Inc., a Maryland corporation ("Assignee").

RECITALS

WHEREAS, Assignor has applied to establish that it is the owner of all right, title and interest in and to the following trademarks, which trademarks have been registered with the United States Patent and Trademark Office as follows (the "Trademarks"):

WHEREAS, Assignor desires to transfer all right, title and interest in and to the Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows.

1. Assignment. Assignor hereby grants, conveys, sells, transfers and assigns to Assignee all of its right, title and interest in and to the Trademarks, and all goodwill associated therewith, pursuant to that certain Assignment Agreement dated as of December 20, 2004 among (a) Starwood Hotels & Resorts Worldwide, Inc., a Maryland corporation, (b) Sansora International, Inc., an Arizona corporation, and (c) Arabella Hotel Holding International GmbH & Co., KG, a German limited liability company (acting solely as guarantor of Assignor's obligations pursuant to that agreement).
2. Recordation. The parties agree that Assignee may record this Agreement with the United States Patent and Trademark Office to evidence the transfer of the Trademarks.
3. Multiple Counterparts. This Agreement may be executed in a number of identical counterparts, each of which constitutes collectively, one Agreement; but in making proof of this Agreement, it shall not be necessary to produce or account for more than one counterpart.
