## ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

THIS ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS is made as of April 1, 2005, by ROYAL BANK OF CANADA, NEW YORK BRANCH ("RBC"), as resigning collateral agent (in such capacity, "**Resigning Collateral Agent**").

### RECITALS:

WHEREAS, Resigning Collateral Agent, HAULMARK INDUSTRIES, INC. (formerly HMK Acquisition Corp.), a Delaware corporation ("**Haulmark Industries**"), UNIVERSAL TRAILER CORPORATION HORSE/LIVESTOCK GROUP (formerly Exiss Aluminum Trailers, Inc.), a Delaware corporation ("**Horse/Livestock Group**"), SOONER TRAILER MANUFACTURING COMPANY (formerly Sooner Acquisition Corp.), a Delaware corporation ("**Sooner**") (Haulmark Industries, Horse/Livestock Group, Universal and Sooner, each a "**Borrower**" and, collectively, the "**Borrowers**"), are parties to security agreements (the "**Security Agreements**") wherein each Borrower granted to Resigning Collateral Agent, a security interest in such Borrower's trademarks and trademark applications, including the trademarks and trademark applications listed on the attached Schedule 1 (the "**Trademark Collateral**");


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:
