**AMENDMENT TO COLLATERAL ASSIGNMENT OF TRADEMARKS
(SECURITY AGREEMENT)**

This Amendment to Collateral Assignment of Trademarks (Security Agreement) (this "Amendment") is made as of March 28, 2005 by and between SMART Modular Technologies, Inc., a California corporation ("Pledgor") and Wells Fargo Foothill, Inc., as administrative agent ("Agent") with respect to the following facts:

A. Pledgor and Agent are parties to that certain Collateral Assignment of Trademarks (Security Agreement) dated April 16, 2004 and recorded with the United States Patent and Trademark Office on May 13, 2004 at Reel 002965, Frame 0891 (the "Agreement").

B. Since the date of the Agreement, Pledgor acquired the trademarks and related registrations and applications set forth on Exhibit A hereto (the "New Trademarks").

C. Pledgor and Agent now desire to amend the Agreement to cover the New Trademarks.

NOW THEREFORE, the Agreement is hereby amended to add the New Trademarks to Schedule A of the Agreement, and the term "Trademarks" as defined and used in the Agreement shall include the New Trademarks. In all other respects, the Agreement shall remain in full force and effect and is hereby ratified and confirmed.


