TRADEMARK ASSIGNMENT

This assignment made as of the 3rd day of March, 2001, by Clinicians Group LLC ("Assignor"), to Jobson Publishing LLC, a Delaware limited liability company ("Assignee").

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby assigns to Assignee all of Assignor's respective right, title and interest in and to the Trademarks and the Registrations, together with any goodwill of the business symbolized by the Trademarks; the right to apply to register the Trademarks additionally in the United States and elsewhere; the right to maintain and renew the Registrations; and the right to sue for damages and other remedies on account of any infringement of any of the Trademarks that may have occurred prior to the date of this Assignment or that may occur in the future.

2. Assignor further agrees to execute any documents and take any action that may be required to confirm or perfect Assignee's right, title and interest in the Trademarks and the Registrations, including, without limitation, the filing of a substitute Power of Attorney in the U.S. Trademark Office, security interests with respect to the Trademarks and the Registrations, and the recordation of this Assignment.
