## TRADEMARK SECURITY AGREEMENT

WHEREAS, Horizon Lines, LLC and Horizon Services Group, LLC (together, the “Pledgors”) have adopted, used and are using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1A, which trademarks and service marks are registered in the United States Patent and Trademark Office (the “Trademarks”);

WHEREAS, the Pledgors, have entered into a Collateral Agreement, dated July 7, 2004 (the “Collateral Agreement”), in favor of UBS AG, STAMFORD BRANCH (the “Collateral Agent”);

WHEREAS, pursuant to the Collateral Agreement, the Pledgors have assigned to the Collateral Agent and granted to the Collateral Agent a continuing security interest in all right, title and interest of the Pledgors in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Obligations (as defined in the Collateral Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Pledgors do hereby pledge, convey, sell, assign, transfer and set over unto the Collateral Agent and grant to the Collateral Agent a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Pledgors do hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

IN WITNESS WHEREOF, the Pledgors have caused this Assignment to be duly executed by its officer thereunto duly authorized as of April 7, 2005.
