

RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is given as of this 1st day of March, 2005, by HSBC Bank USA, National Association, (formerly known as HSBC Bank USA), a National Banking Association, located at 452 Fifth Avenue, New York, NY 10018-2706, in its capacity as Joint Collateral Agent for the Secured Parties, (the "Assignor"), in favor of Hexcel Corporation, a Delaware Corporation, located at 11711 Dublin Blvd., Dublin, CA 94568, ("Assignee"), as follows:

WHEREAS, Assignee and Assignor, among other parties, entered into a Pledge and Security Agreement dated March 19, 2003 (the "Security Agreement") and a Trademark Security Agreement, dated as of March 19, 2003 ("Trademark Security Agreement"), which was recorded with the U.S. Patent and Trademark Office, at Reel 2710 / Frame 0805;

WHEREAS, pursuant to said Security Agreement and Trademark Security Agreement, Assignee granted to the Joint Collateral Agent, for the benefit of the Secured Parties, a security interest and continuing lien on all of Assignees' right, title and interest in, to and under all the following whether then owned or existing or thereafter acquired or arising and wherever located, (the "Trademark Collateral"):

- (i) all United States, state and foreign trademarks, service marks, certification marks, collective marks, trade names, corporate names, d/b/as, business names, fictitious business names, internet domain names, trade styles, logos, other source or business identifiers, designs and general intangibles of a like nature, rights of publicity and privacy pertaining to the right to use names, likenesses and biographical data, all registrations and applications for any of the foregoing including, but not limited to, the registrations and applications referred to on Schedule I hereto (as such schedule may be amended or supplemented from time to time);
- (ii) the goodwill of the business symbolized by the foregoing, the right to sue for past, present and future infringements or dilution of any of the foregoing or for any injury to goodwill;
- (iii) all proceeds of the foregoing, including without limitation, royalties, income, payments, claims, damages, and proceeds of suit;
- (iv) any and all agreements granting any right in, to or under Trademarks to which Assignee is a party (whether such Assignee is licensee or licensor thereunder) including, without limitation, each agreement referred to in Schedule I hereto (as such schedule may be amended or supplemented from time to time); and
- (v) to the extent not otherwise included above, all Proceeds, products, accessions, rents and profits of or in respect of any of the foregoing; and

WHEREAS, Assignee has satisfied its obligations under the above-referenced Security Agreement, Trademark Security Agreement and the related Indenture, and Assignor desires to release its and security interest and continuing lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security intent and continuing lien on the Trademark Collateral and reassigns any and all interest that it may have therein to Assignee.

All capitalized terms used but not defined herein shall have the respective meanings ascribed to them in the Security Agreement.
