**MEMORANDUM AND NOTICE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

Sunstate Equipment Co., LLC, a Delaware limited liability company, whose address is 5425 E. Washington Street, Phoenix, Arizona 85034 ("Grantor") hereby acknowledges the following:

Grantor and Bank of America, N.A., with an office at 55 South Lake Avenue, Suite 900, Pasadena, California 91101 (as administrative agent for the Lenders, the "Agent"), are party to that certain Credit Agreement, dated as of April 8th, 2005 (as amended, modified, renewed or extended from time to time, the "Credit Agreement") by and among the Grantor, the Agent and the financial institutions from time to time party thereto (the "Lenders"); and


Under the terms of the Credit Agreement and that certain Security Agreement, dated as of April 8th, 2005 (as amended, modified, renewed or extended from time to time, the "Security Agreement"), entered into between the Grantor and the Agent, Grantor has granted to the Agent, for the ratable benefit of the Lenders, a security interest in the trademarks and trademark registrations and applications therefor which are identified on Schedule A attached hereto and incorporated herein by this reference (the "Trademarks"), together with the goodwill thereto, owned by Grantor, which Trademarks are appurtenant, and all actions for infringement concerning the foregoing.

Nothing contained in this Memorandum and Notice of Security Interest in Intellectual Property shall be construed as a present or absolute assignment of any of the collateral nor as limiting any interest which the Agent may have in any other collateral described in the Security Agreement or otherwise. Capitalized terms used but not defined herein shall have the meanings given them in the Credit Agreement.

Subject to the provisions of Section 26(a) of the Security Agreement, this Memorandum and Notice of Security Interest in Intellectual Property shall terminate upon the satisfactory collateralization of all Letters of Credit and the payment in full of all other Obligations (other than indemnification Obligations as to which no claims have been asserted).
