### **Articles of Amendment of Hoopa, Inc.**

The shareholders of Hoopa, Inc. have approved the following articles of amendment:

#### **Amendment to change ARTICLE I. Name**

The shareholders of Hoopa, Inc. adopted the following amendment on October 22, 1999 to change ARTICLE I. of Hoopa, Inc.'s Articles of Incorporation to state:

The name of the corporation is Tyzo.com, Inc.

#### **Amendment to change ARTICLE II. Stock**

The shareholders of both Class A and Class B common stock of Hoopa, Inc. adopted on October 22, 1999 the following amendment to change ARTICLE II of Hoopa Inc.'s Articles of Incorporation to state:

There will be three (3) classes of Stock: Class A preferred stock, Class B common stock and Class C preferred stock. The corporation is authorized to issue two million (2,000,000) shares of Class A preferred stock, five million, eight hundred and fifty thousand (5,850,000) shares of Class B common stock and one hundred and fifty thousand (150,000) shares of Class C preferred stock. The terms of class A preferred stock shall be determined by the board of directors before the issuance of any shares. Shares of class B common stock shall have no par value and full voting rights. Shares of Class C preferred shall have a par value of 29 cents per share, no cumulative dividend rights, no voting rights, and shall be convertible on a 1:1 basis into class B common stock.

#### **Provisions for implementing the amendment to change ARTICLE II. Stock**

Holders of Class A common stock shall have their shares converted into the new Class B common stock on a 1:6 basis receiving six (6) shares of Class B common stock in exchange for one (1) share of Class A common stock.

Holders of Class B common stock shall receive six (6) shares of the new Class B common stock in exchange for one (1) share of their old Class B common stock.

#### **Shares Outstanding and Voted**

The above amendments were approved by all the shareholders of the corporation

300,000 shares of Class A common and 400,000 shares of Class B common were outstanding and thus eligible to vote on these Articles of Amendment.

All 300,000 shares of Class A common were voted in favor of approving these Articles of Amendment.

All 400,000 share of Class B common were voted in favor of approving these Articles of Amendment.
