Whereas, the Original Assignee is party to a certain Security Agreement dated May 30, 2003, (the "Security Agreement") pursuant to which Sunshine Bouquet Company (the "Borrower") granted to the Original Assignee a security interest in certain assets of the Borrower described in the Security Agreement and identified in Exhibit A attached hereto:

Whereas, effective February 11, 2005, the New Assignee acquired a portfolio of business loans from the Original Assignee and included among the acquired loans were one or more loans to the Borrower;

Whereas, effective February 11, 2005, the Original Assignee assigned all of its rights, title and interests in the loan documents between the Borrower and the Original Assignee to the New Assignee, including, without limitation, the Security Agreement;

Now, Therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, this will confirm that Original Assignee has sold, assigned and transferred to the New Assignee, its successors or assigns, all right, title and interest of the Original Assignee in and to a certain security interest and debt thereto issued to the Original Assignee from the Borrower, as described more fully in the Security Agreement, pursuant to that certain Purchase and Sale Agreement dated as of February 11, 2005.
