MEMORANDUM OF TRADEMARK AND SERVICE MARK SECURITY INTEREST

This Memorandum is dated as of February 22, 2005 between Denali Incorporated, a Delaware corporation having a place of business at 2400 Augusta Drive, Suite 340, Houston, TX 77057, and Containment Solutions, Inc., a Delaware corporation having a place of business at 5150 Jefferson Chemical Road, Conroe, Texas 77301 (collectively, the "Mark Owners"), and The CIT Group/Business Credit, Inc., a New York corporation having a place of business at 900 Ashwood Parkway, Suite 610, Atlanta, GA 30338, as agent (the "Secured Party") for itself and the other lenders under the Financing Agreement (as defined below).

1. The Mark Owners have the capacity to grant to the Secured Party the security interests granted under the Financing Agreement.
